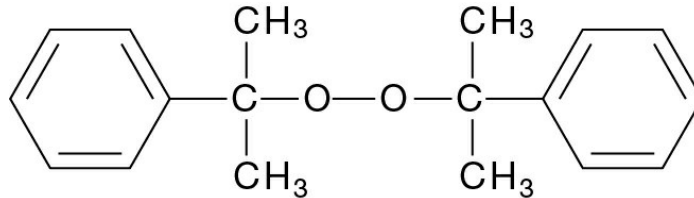


Perkadox BC-40K-PD

General purpose dialkyl peroxide, 40% active ingredient on kaolin clay in powder form for ease of dispersion in an elastomer compound, especially used where moisture prevention is preferred.

Applications

Perkadox BC-40K-pd is used for the crosslinking of natural and synthetic rubbers, as well as thermoplastic polyolefins. Rubber compounds containing Perkadox BC-40K-pd combine good processing safety with a fair speed of cure.

Thermal stability

Organic peroxides are thermally unstable substances, which may undergo self-accelerating decomposition. The lowest temperature at which self-accelerating decomposition of a substance in the original packaging may occur is the Self-Accelerating Decomposition Temperature (SADT). The SADT is determined on the basis of the Heat Accumulation Storage Test.

SADT	80°C (176°F)
Method	The Heat Accumulation Storage Test is a recognized test method for the determination of the SADT of organic peroxides (see Recommendations on the Transport of Dangerous Goods, Manual of Tests and Criteria - United Nations, New York and Geneva).

Storage

Due to the relatively unstable nature of organic peroxides a loss of quality can be detected over a period of time. To minimize the loss of quality, Nouryon recommends a maximum storage temperature (Ts max.) for each organic peroxide product.

Ts Max.	30°C (86°F)
Note	When stored under the recommended storage conditions, Perkadox BC-40K-pd will remain within the Nouryon specifications for a period of at least six months after delivery.

Packaging and transport

In North America Perkadox BC-40K-pd is packed in non-returnable poly-lined cartons of 50 lb net weight. In other regions the standard packaging is a cardboard box for 20 kg peroxide formulation. Both packaging and transport meet the international regulations. For the availability of other packed quantities consult your Nouryon representative. Perkadox BC-40K-pd is classified as Flammable solid, class 4. 1, UN 1325.

Safety and handling

Keep containers tightly closed. Store and handle Perkadox BC-40K-pd in a dry well-ventilated place away from sources of heat or ignition and direct sunlight. Never weigh out in the storage room. Avoid contact with reducing agents (e. g. amines), acids, alkalines and heavy metal compounds (e. g. accelerators, driers and metal soaps). Please refer to the Material Safety Data Sheet (MSDS) for further information on the safe storage, use and handling of Perkadox BC-40K-pd.
